<b>Formulation:</b>	IgG in phosphate buffered saline (without Mg <sup>2+</sup> and Ca <sup>2+</sup> ), pH 7.4, 150 mM NaCl, 0.5% BSA, 0.02% sodium azide and 50% glycerol.
<b>Stability:</b>	Stable. Not a significant hazard in these quantities.
<b>Corrosiveness:</b>	Mildly corrosive to aluminum. Moderately corrosive to copper and lead (azide only).
<b>Storage Conditions:</b>	Refrigerator storage recommended (2-8°C or -20°C for long term storage).
<b>Materials to Avoid:</b>	Strong acids, strong alkalis, strong oxidizing agents

**Control parameters:** Not known. Contain no substances with occupational exposure limits.
